In obedience to an order of the Bullitt County Court, we the undersigned commissioners, appointed by said Court, for the purpose of running out and dividing a certain tract of land, now owned by Nathaniel P. Saunders heirs, we proceeded on the 24th day January 1861 and in conjunction with the Surveyor of Bullitt County, and after first were duly sworn, run out the whole boundary in order, so as to ascertain the true number of acres contained in said boundary, after which, we divided the same between the heirs as laid down and explained on the within Report as follows.

Lot No. 1. We allotted to Francis Miller, wife of Peter Miller, with the following Boundary. Beginning at a Stake in the middle of the Maulick's road. Corner to N.P. Saunders one acre Lot. Thence with a line of said Lot No. 29. 618 poles to a Stake on the East Edge of the Turnpike in Robert Hough's Land. Thence with the Turnpike N 26 3/4 W 36 1/2 poles to a Stake corner to Leonidas J. Saunders; Thence with his line S 29 W 35.5 poles to a Stake in the middle of the Maulick Road, Thence with said road S 68 1/2 E 4 poles. S 66 E 18 poles to the Beginning. Containing 3 acres. 2. rd. 25 poles.

Lot No. 2. We allotted to Leonidas J. Saunders with the following Boundary. Beginning at a Stake in the Maulick road, corner to Francis Miller's Lot. Thence with her line N 29 E 35.5 poles to a Stake on the East Edge of the Turnpike in Robert Hough's Land. Thence with the Turnpike N 26 3/4 W 13 poles 4 links. N 23 1/2 W 6 poles. 6 links to a Stake, corner to Joseph Saunders's Lot. Thence with his line S 29 W 48 poles. 15 links to a Stake in the Maulick Road, division corner to Cleombrotus Saunders Thence with the road S 68 1/2 E 16 poles to the Beginning. Containing 4. acres. 25 poles.

Lot No. 3. We allotted to Joseph Saunders with the following boundary. Beginning at a Stake on the East side of the Turnpike, corner to Leonidas Saunders's Lot. Thence with the Turnpike N 23 1/2 W 3 1/2 poles 13 links to a Stake, division corner to George Saunders. Thence with his line S 29 W 30 poles. 17 links to a Stake, division corner to George Saunders. Thence with Cleombrotus Saunders's line S 29 E 32 1/3 poles to a Stake in Leonidas Saunders's line and corner to Cleombrotus Saunders's Thence with Leonidas Saunders's line N 29 E 36 3/4 poles to the Beginning. Containing 4 acres. 3 rods. 9 poles.

Lot No. 4. We allotted to George Saunders with the following Boundary. Beginning at a Stake on the East Edge of the Turnpike division corner to Joseph Saunders; Thence with
