Edward D. Rogers of Spencer County in the State of Kentucky do make and give in this my last Will & Testament. I constitute my brother in Law Henry Cheek my Executor of this my Will it is my Will and desire that all of my Estate be equally divided between John Rogers Wholier in Spencer County my Brother and Sarah Mc Cheek and her bodily heirs of the above County in my Will that my Estate be divided between my Brother and aforesaid Sister and here in the following manner first it is my Will that all of my part of Robert Douglass Estate which he willed to me be divided equally between John Rogers and my Sister Sarah Mc Cheek and here as before named my Guardian Henry Cheek and Executor will account to the County Court for a miced of my Estate as I have received from Thomas Robinson who is the Executor of my Grandfather Roberts Douglass Will the part of my Estate which I have received from Robert Douglass Estate is three hundred Dollars. I Will and desire is that my just Debts and expenses be taken out of the three hundred Dollars which I have received and the balance divided between my Sister and brother as before directed. I Will and bequeth my interest in a certain Negro Woman named Marion to my Brother and Sister Sarah Mc Cheek and John Rogers. I also Will my Riding horse and forty dollars which my brother in Law Henry Cheek owes me to my brother and Sister In testimony whereof I hereunto set my hand and seal the
