

### **Foundation Report**

Rachel Evey, Executive Director

Wentachee Valley College Foundation has been busy planning activities and opportunities for 2023-24. The foundation's executive committee also had its first retreat to discuss priorities and potential strategic goals in preparation for the full board retreat. The full board retreat will be held in early 2024 once the new WVC strategic plan is released that way the foundation's strategic goals are through the lens of WVC's goals and the foundation's SWOT analysis from 2022-23.

Community Engagement

- I am serving as the board's president this year. This is a professional development and networking nonprofit for estate planning professionals. Most members are attorneys, accountants, or financial advisors.
- The foundation is helping the ASPIRE department for the new strategic plan. Specifically, the foundation is identifying and securing locations across the district for public listening sessions, in partnership with local community organizations.
- The foundation is leading the Chamber Community Leadership class's visit to WVC on November 3. The agenda will include speakers from across programs at WVC.
- Together with athletics director Matthew Vargas, met with Visit Wenatchee's new sports tourism coordinator to discuss opportunities and partnerships to promote WVC athletics.
- Attended the relaunch of Young Professionals of NCW meetup. Previously a grassroots organization, I served on the planning team before 2020. YPNCW is now exploring opportunities as a partner of the Wenatchee Valley Chamber of Commerce.
- Attended Partners in Economic Development with the Chelan Douglas Regional Port Authority. During the event, engaged a number of community leaders and major donors.

### **Donor Engagement**

- The Wenatchee Rotary Club approved a grant for the WVC Bridge program, which provides financial support to Adult Basic Education students pursuing their high school diploma and college-level courses.
- The foundation will be conducting an employee giving campaign in September, launching after Labor Day and concluding on Food Truck Knight (September 29). This will include a solicitation at Kickoff Day (President's Day) for employees to sign up for payroll donations.
- The foundation is providing substantial assistance to athletics for their fundraising efforts, including events.

### Scholarship Program

- \$270,000 has already been awarded for 2023-24 through renewal awards.
- The fall application is currently open, closing October 1 (after the first week of classes). A projected \$150,000 will be awarded through the fall cycle.

### Internal

• WVC-WVC Agreement: The updated agreement between Wenatchee Valley College president and Wenatchee Valley College Foundation board of directors was adopted in June 2023.

- Audit: The foundation budget and finance committee will review year-end financial statements on September 5. If approved, the foundation will begin its audit September 18. Audited financial statements will be provided to WVC for their audit.
- Development director: The foundation board of directors approved the funding for a new position: development director. The primary duties will be alumni relations, annual giving, and business relations. Cabinet subsequently approved the position. Applications will be accepted through mid-September.
- New board member: Jessica Gilmore has joined the foundation board. She was recommended by former board member Sara Lippert. Jessica has a past career in education and currently works at AWS Academy.
- New board officers: This year, Joshua Wood (Confluence Health) serves as president, Jorden Jessup (Jessup Real Estate) serves as vice president, and Jennifer Babcock (Cordell Neher) serves as treasurer.






# Enrollments by Funding Source

### 2023-2024 Operating Budget

### Brett Riley, Vice President of Administrative Services

The WVC 2022-23 operating budget is presented here for Board of Trustee approval in October. Included is a summary of the sources of funds and the rationale of budgetary decisions based on enrollment forecast and legislative action.

### **Revenue Forecast:**

### 101 Funds-

• Our state allocation is projected to be **\$22,451,075** including provisos and program funding.

### 149 Funds-

• Tuition forecast is **\$6,679,408** for the academic year 2023-24. This reflects a **2.5%** increase in tuition rate and flat enrollment.

### 148 Funds-

• Fee revenue is projected to come in at **\$1,790,766.** Fee revenue reflects the proposed changes to the fee schedule and enrollment decline.

### 146 Funds-

• Revenue from Running Start decreased significantly from the previous year. We are expecting FY23 Running Start revenue to come in at **\$5,389,392** reflecting an average **4%** in K-12 reimbursements.

### Other-

• \$120,000 in WVC Foundation sourced funds dedicated to specific endowed agriculture instruction and equipment.

### Base Operating Revenue- \$36,430,641

### **Total Operating Revenue**

WVC has anticipated 2023-24 base operating expenses of \$36,231,377.

Net \$199,264

#### **CELEBRATING SUCCESS**

#### **Distinguished Alumni, Dennis Carlton**

The Wenatchee Valley College Foundation Board of Directors has selected **Dennis Carlton** as the 2023 Distinguished Alumni Award recipient. The foundation received nominations for 12 alumni from across North Central Washington.

"This award was totally unexpected," Carlton said. "WVC has been a part of me every step of the way. College should be a leaping point for everybody. Education is an opportunity to expand who we are and what we are."

After growing up in Omak, Carlton enrolled at WVC in 1965 and attended classes on the Wenatchee campus since there was no Omak campus at the time. He said WVC professors made a significant impression on him. After graduating from WVC with his associate degree, he went on to receive a bachelor's degree in education with an emphasis in business from Eastern Washington University. Carlton began his career in 1970 with the Omak School

District teaching business classes through the DECA high school business and entrepreneurial program. He later taught business classes at the WVC at Omak campus. Carlton then changed careers from education to business. In addition to owning and operating a variety of Omak businesses, Carlton has worked as a New York Life Insurance agent for over 47 years, receiving a variety of awards and achievements from the company.

Carlton is known for civic-mindedness, community leadership, small business advocacy and mentoring young entrepreneurs. He has held many leadership positions such as president of the Omak Performing Arts Foundation, president of the Omak Chamber of Commerce, president of the Loup-Loup Ski Foundation, president of Rotary Club of Okanogan-Omak, board member of the WVC Foundation at Omak and chairman of the Omak School Board.

The WVC Distinguished Alumni Award began in 1975 to recognize alumni who have distinguished themselves in their chosen professional field; made significant contributions to their community on a local, state, national or international level; and have demonstrated integrity in their personal life and gained the respect of their peers.

Students also had recreation time. After a 13-hour flight from Misawa to Seattle, and a 2 ½ hour drive to Wenatchee students had the energy to play a competitive game with the WVC's volleyball team

### **Administrative Services**

- Administrative Services continues to work with facilities and campus stakeholders to complete the design of the CTEI building. The design process is largely complete. We are currently evaluating site placement related to ongoing conversations with CWU.
- Administrative Services is now working with the city to evaluate real estate acquisition in Omak in an effort to secure the footprint and necessary parking for the new Omak Health Science Center.
- Administrative Services will be participating in another NWCCU year-six Policies, Regulations, and Finances Review (PRFR) panel in October.

### **Budget & Internal Auditing**

• WVC has hired a new budget and internal audit position that will be assuming supervision of the operating budget. We have included the proposed 23-24 Operating Budget for your review in the September board packet.

### **Fiscal Services**

- Fiscal Services successfully concluded the year-end process for the FY22-23 fiscal year.
- Fiscal Services continues to progress on financial statement audits for 21-22 and 22-23. The staffing at CLA has been more impactful than previously expected, but we believe we are nearing completion.

### **Facilities and Capital**

- Omak Health Sciences Center- The project is currently on pause as we await additional funding through grants and the federal earmark process.
- CTEI As stated prior, CTEI design is largely complete, subject to site selection that is dependent on our partnership with CWU.

### **Minor Works**

• Facilities staff are currently moving through the DES process to start a number of minor works projects that will be shared at the Board work session.

### Safety and Security

• Safety staff along with IT and Facilities spent the summer evaluating our security camera vendors and infrastructure. We have requested and received demonstrations from two of the premier vendors in the market and have received quotes to serve both our Omak and Wenatchee campus. The team has identified a preferred vendor and will be moving forward with a deployment plan subject to funding availability.

### **Information Technology**

• IT Staff participated in the first annual NWCCT summit. This was the first gathering of its kind that brought together IT representatives from across the northwest to address emerging issues and concerns in the area of cybersecurity threat assessment and recovery. A summary of our staff participation in this summit will be presented at the September Board meeting.

WVC Student Affairs Update

September 2023



CAMP, one of WVC's most highly successful student support programs, is a federally funded program designed to help students from migrant and seasonal farm working backgrounds during their first year of college. The program staff (see below) provide academic and financial support services to empower students, so they have a strong foundation to build upon as they work toward a bachelor's degree. CAMP at WVC has been in existence since 2009 and is now in its 5<sup>th</sup> year of its grant. It will be in rewrite this 2023-2024 school year and strive to ensure CAMP remains at WVC for another 5 years.

### Director – Levi Vega-Sanchez

Levi has been with the program since August 2021, and leads the team in ensuring that CAMP continues its model of excellency. Ensuring that all scholars receive excellent services, guidance to first-year completion, and preparing them to be successful beyond the classroom. Levi also serves as the primary professor for CAMP's SDS 107 and SDS 108 course where students are taught valuable academic, career, and life skills.

### Retention Specialist – Dulce Morgado

Dulce joined CAMP in April 2023 and has impacted CAMP right away by contributing to CAMP's successful completion rate for 2022-2023. Dulce assists CAMP in providing appreciative advising, implementing retention and engagement strategies, and empowering our students to believe that they will be successful.

### CAMP Recruiter – Laura Guillen Reyes

Laura joined CAMP in January 2023, has hit the ground running. She has successfully ensured that CAMP meets its recruitment numbers of 55 students per school year. Laura has also continued CAMP's work in having great partnerships with community partners like Café, OIC of WA, SkillSource, and more importantly, school districts across Chelan, Okanogan, and Douglas County.

### Program Coordinator – Evelyn Mejia Naranjo

Evelyn has been with CAMP since April 2020, is CAMP's glue and longest tenured staff member. Her phenomenal work to ensure the program is running at an elite level is unmatched. She has successfully ensured that CAMP is meeting program objectives, completing financial reports ahead of schedule, and oversees our CAMP mentorship program. Evelyn has been a crucial figure in CAMP's success since she joined CAMP.

### Updates:

- In the Spring quarter, CAMP was able to celebrate 40 2<sup>nd</sup> year graduates who were enrolled in CAMP during their first year of college. These scholars will now be transferring to a 4-year institution, continue their enrollment here at WVC through technical programs, or enter the workforce. For context, these graduates were a part of Cohort 13 (2021-2022). Out of 55 scholars, 15 had graduated in 2022 and now the remaining cohort graduated June 2023.
- CAMP also saw 60 first-year students successfully complete their first year of college. CAMP's retention rate for this upcoming Fall 2023 is 96%.
- For the 2022-2023 school year, CAMP awarded \$72,000 in scholarships to our 1<sup>st</sup> year students enrolled in the program. This assisted students in easing financial insecurity that attending college brings.
- CAMP successfully partnered with the North Central Educational Service District (NCESD) this Spring quarter to host Migrant Leadership Day. At this event, over 130 migrant high school students from counties across our territory attended and received leadership workshops, campus tours, and the ability to apply to WVC and its support programs like TRIO SSS, CAMP, & MESA while visiting us.

### 500.400 REASONABLE ACCOMMODATION POLICY

This policy affirms the commitment of Wenatchee Valley College to provide reasonable accommodations for applicants or employees with disabilities in order to ensure equal terms, benefits, privileges, and conditions of employment. This policy sets forth the provisions for meeting reasonable accommodation requirements of State and Federal law. This policy shall not be construed as providing rights or obligations greater than those provided by applicable laws. The college has developed policies and procedures for providing reasonable accommodation for disabled employees and candidates for employment. The authority for these procedures is found in:

Americans with Disabilities Act of 1990

Rehabilitation Act of 1973

Chapter 49.60 RCW

Chapter 357-26 WAC

Governor's Executive Order 96-04

Persons with disabilities have the right to request and receive reasonable accommodation in all aspects of employment with the college, including but not limited to: application; recruitment; selection/hiring; promotion; testing; medical examination; layoff/recall; assignments; termination; evaluation; compensation; disciplinary actions; leave; training; the terms, conditions and benefits of employment, including insurance benefits and employer supported activities, unless such accommodation represents an undue hardship to the college.

Reasonable accommodation means modification or adjustment to a job, work environment, policies, practices or procedures that enables a qualified individual with a disability to enjoy equal employment opportunity. "Person with a disability" means a person with a physical or mental impairment that substantially limits one or more major life activities. Further written materials on this program are available from human resources.

This policy, together with the implementing procedures, is intended to provide guidance to the WVC District and the individual in instances where reasonable accommodation may be indicated.

This policy should not be construed as providing rights or obligations not provided under applicable law.

The <u>executive director of human resources</u>-director or designee is responsible for implementing this policy and the respective procedures.

### 500.140 CHILD ABUSE OR NEGLECT REPORTING POLICY

### A. POLICY STATEMENT

It is the policy of Wenatchee Valley College, in accordance with <u>RCW 26.44.030</u>, that all employees report child abuse or neglect as described below. The report must be made at the first opportunity, and never later than 48 hours after the college employee has reasonable cause to believe that a child has suffered abuse or neglect.

### B. DEFINITIONS (<u>RCW 26.44.020</u>)

Child: Any person under the age of 18 years of age.

Abuse or neglect: Sexual abuse, sexual exploitation, or injury of a child by any person under circumstances which cause harm to the child's health, welfare, or safety, or the negligent treatment or maltreatment of a child by a person responsible for or providing care to the child.

Abused child: A child who has been subjected to child abuse or neglect.

Allowable physical discipline: physical discipline that is reasonable and moderate and is inflicted by a parent, teacher, or guardian for purposes of restraining or correcting the child. Any use of force on a child by any other person is unlawful unless it is reasonable and moderate and is authorized in advance by the child's parent or guardian for purposes of restraining or correcting the child. (RCW 9A.16.100)

### C. REPORTERS

Academic (faculty), administrative and athletic employees, including student employees must make any report directly to the proper law enforcement agency or the department of social and health services.

All other employees must make any report directly to the executive director of human resources via phone, in person or email. The executive director of human resources must make report to the proper law enforcement agency or the department of social and health services.

#### D. ELEMENTS OF REPORT

The report must include as much detail as possible and must include the identity of the accused if known. Detail includes:

- 1. The name, address and age of the child.
- The name and address of the child's parents, stepparents, guardians or other persons having custody of the child.
- 3. The nature and extent of the alleged injury or injuries.
- The nature and extent of the alleged neglect.
- 5. The nature and extent of the alleged sexual abuse.
- Any evidence of previous injuries, including their nature and extent.
- Any other information that may be helpful in establishing the cause of the child's injury, injuries or death.
- The identity of the alleged perpetrator or perpetrators.

The reporting requirement above does not apply to the discovery of abuse or neglect that occurred during childhood if it is discovered after the child has become an adult. Wenatchee Valley College BOARD POLICY STATEMENT 500.000 HUMAN RESOURCES

However, if there is reasonable cause to believe other children are or may be at risk of abuse or neglect by the accused, the reporting requirement does <u>apply</u> and a report must be made.

### E. TRAINING

Wenatchee Valley College ensures that it communicates this policy to all employees such that all employees have knowledge of their reporting responsibilities.

### F. IMMUNITY FROM LIABILITY

Any person who participates in reporting alleged child abuse or neglect in good faith shall be immune from any legal liability arising out of such reporting.

A person who, in good faith, cooperates in an investigation of a report of child abuse or neglect shall not be subject to civil liability arising out of his or her cooperation.

However, a person who, intentionally and in bad faith, knowingly makes a false report of alleged abuse or neglect shall be guilty of a misdemeanor and violation of college policy.

### G. REPORTING GUIDANCE

The executive director of human resources is the college's designee to receive reports and provide guidance regarding an employee's reporting obligations.

### 560.100 FACULTY TENURE AND DISMISSAL POLICY
