1. March 17, 2021, Board Meeting Minutes

MOTION NO. 2358

Steve Zimmerman moved that the minutes of the March 17, 2021 board of trustees meeting minutes be approved. The motion was seconded by Wilma Cartagena and carried unanimously.

CELEBRATING SUCCESS

2. Audit

Recently, the WVC Fiscal Services department was called out in a campus recognition email, called the Friday Kudo's. In light of recent success and triumphs, Cabinet has determined that a kudo's did not adequately recognize the achievement of Fiscal Services, more specifically, their Director Janice Fredson.

What warrants celebration is that through budget cuts, loss of personnel, ctcLink link preparation, transition and implementation, COVID 19 pandemic, and a gauntlet of audits (5 audits over 18 months) Janice and her team have kept us all on a principled fiduciary path. WVC has successfully completed each financial statement audit with consistent and marked improvement, with each of the last four audits being clean and finding free (three financial statement audits). At a recent audit exit meeting, the State Auditor's Office made a point of thanking and recognizing Janice's work on the recent audits as well as noting the tremendous improvement in the college's financial condition in such a short period of time.

As stated in the kudo's, "what has been truly astonishing is the caliber of work our Fiscal Services team was able to accomplish amidst the noise of ctcLink." It is worth noting that not all audits are created equal, while financial statement audits evaluate the accuracy of an institution's financials, an accountability audit evaluates the legal and ethical use of our resources. When we ask ourselves as an institution if we are doing our work ethically and accurately, the results of the last four audits tell us, **Yes.** For that, we owe Janice a tremendous amount of appreciation.

3. First Generation Banquet

On April 8, 2021 the Department of Diversity, Equity, and Inclusion celebrated its 3rd annual, First Generation Celebration. This event helps celebrate and create community among our first-generation students, staff, and faculty. We showcased profiles that students, staff, and faculty shared with us.

As first generation college students, they face certain challenges. When a student chooses to attend college, they can experience a shift in identity, leading to a sense of loss. Not prepared for this loss, many first-generation students may come to develop two different identities — one for home and another for college. Although perhaps supportive of higher education, their parents and family members may view their entry into college as a break in the family system rather than a continuation of their schooling. Campus Life at WVC recognizes the importance of sharing the stories and successes of our students, staff, and faculty past and present.

The guest speaker was Analee Calvillo. She is a WVC alumna. Analee is the Program Manager/Latinx Outreach for the non-profit GWATA rebranding to NCW Tech Alliance located in Wenatchee. She earned her Master's degree in Public Administration from Eastern Washington University, where she studied public and non-profit management with an emphasis on serving Latinx students in higher education. As a first-generation student, she spoke about her obstacles and what it took to overcome them. Analee finds in her community mentors, leaders, and advocates that helped shape her into the strong, resilient Latina she is today.

4. One College, One Book

This winter, WVC announced the One College, One Book program. The aim of this program is to create a space for the WVC faculty and staff community to gather and discuss big ideas that affect all of us here in North Central Washington. With the help of an interdisciplinary committee of our peers, we selected *The Book of Unknown Americans* because it centers on communities and topics central not only to our service district, but to our country as a whole. As a Hispanic Serving Institution that offers programs and grants to immigrant and undocumented students and their families, the characters in this book are fictional, but not unreal. Their experiences are real and reflective of the experiences of our friends, family, neighbors and colleagues.

The WVC Foundation generously contributed funds toward bringing the book's author, Cristina Henríquez, in for a virtual visit on April 15, 2021 at 7 pm PST. <u>Registration for this event</u> was open to the public, as the WVC Libraries proudly partnered with NCW Libraries for this event. President Richardson contributed funds toward the purchase of 50 copies of the book, which were distributed to program participants.

The faculty and staff discussions on April 13 were lively and meaningful. Participants expressed that they were extremely interested in continuing this program as a twice-yearly event!

5. All-Washington Academic Team

The All-Washington Academic Team program recognizes and honors our state's finest higher education students. The students who make up the All-Washington (All-WA) Team reflect the diversity of the state, maintain high standards of excellence, and contribute positively to the community.

Wenatchee Valley College students **Heather Coffman** and **Kaila Harmier** were recognized as members of the 2021 All-Washington Academic Team during a virtual ceremony on April 15, 2021.

After waitressing for years, Heather made the decision to switch careers to something she is passionate about. By earning her Bachelor of Applied Science in Nursing, Heather hopes to provide a more comfortable life for her children while showing them the importance of doing work that is meaningful to them. Heather plans to help deliver babies and comfort new mothers by continuing her education and becoming a Certified Nurse Midwife.

When Kaila dropped out of college eight years ago, her mother was disappointed. Her mother had always been very supportive and wanted Kaila to get her education. Four years later, her mother died of cancer and Kaila made a commitment then to get her nursing degree. By keeping the promise she made to her mother, Kaila hopes to show her two daughters that they can accomplish anything they set their mind to.

WVC & ASWVC in partnership with the YWCA held 4 events this year for our 5th annual Stand Against Racism Week.

April 27th at 12:00 was a keynote speaker Teresa Zepeda who spoke on Racism as a public health crisis and specifically the impact on the Latinx community in Wenatchee. We had 68 people tune in for this virtual event which was offered in Spanish and translated to English.

April 28th at 6:00pm we had a panel made up of Dr. Bindu Nayak of Confluence Health, Meleah Butruille WVC Nursing Faculty, Mary Big-Bull Lewis local Indigenous community leader, and Andy Joseph Jr. Colville Tribal member and Indian Health Board member. We had around 20 people participate in this event with great questions for the panelists about how to increase trust and improve racial bias in our health care systems.

April 29th at 4:00pm the ASWVC held a march to Stand Against Racism which started at the YWCA thrift store downtown and marched to Memorial park downtown Wenatchee. We had around 65 people attend the March and were recognized on the front page of the Wenatchee World. The mayor's office signed and read a proclamation in support of the event.

April 30th at 4:00pm the Omak ASWVC held a march to Stand Against Racism which started and ended in the central park in Omak. Administrative Services

- Administrative Services staff continues to participate in statewide COVID meetings as well as weekly Business Affairs Commission (BAC) meeting.
- Admin. Services received positive feedback from Congressman Newhouse's office concerning a \$2.5 million earmark request. More information will be shared at the May Board Work Session.
- Administrative Services staff participated in the inaugural Year-Six Policies Resources Financial Resource Review Process for NWCCU. The year-six process takes a deeper look at the fiscal health of member colleges and universities. WVC is well positioned to participate in this process when we reach year six of our accreditation cycle.
- Administrative Service served as liaison to Wenatchee School District during a statewide testing event. There should be a press release in the weeks to come.

Budget & Internal Auditing

- Budget staff is finalizing the 2021-2022 operating budget and building control tables in ctcLink for the 2021-22 budget year.
- We now have "beta" tools for review budget. Select fiscal services staff are reviewing the tool for accuracy and modification. The tool may be ready for demonstration at the May Board meeting.

Fiscal Services

- ctcLink activities remain the primary focus of Fiscal Services. Specifically, Fiscal Services is beginning their first yearend close in ctcLink.
- Fiscal Services currently has several open positions and will be focused on training new staff in ctcLink and Fiscal Services procedures.

Facilities and Capital

- Wells Hall- The Well Hall project is still going well and remains on schedule. Our IT staff continue to work through the technology plan for Wells, and their team will be working on the technology plan through summer.
- Minor Works- WVC facilities staff continue to work towards completing all minor works projects by the end of the biennium. Reappropriation of two projects was approved by the legislature and will commence after July 1.

Safety and Security

• SSEM staff are currently working through the state procurement process to consolidate campus security under one umbrella for both Omak and Wenatchee. This planning is still preliminary. More information will be available when we are closer to a resolution.

The Student Services area has been focusing on end of year activities (i.e., graduation, COVID relief awarding, guided pathway efforts, etc.) while learning ctcLink and adapting to new processes. The team is also preparing for next year with admission, intake advising/registration, financial aid processing, fielding residence hall inquiries, etc.

The Student Services Leadership Team (SSLT), comprised of Dr. Flores' direct reports, meets every two weeks. In addition to The team has been discussing plans for a phased-in reopening that will allow face-to-face meetings and interaction with students. At this time, we anticipate meeting with students on an appointment only basis beginning sometime this summer. In April 2021, SSLT also decided to change the process and format for submitting monthly board reports.

Effective May 2021, Dr. Flores will be submitting reports that will showcase specific student services departments. This month's report highlights the work that **Lisa Foster**, **Director of Student Access**, has been engaged in and leading.

STUDENT ACCESS

The student access department has received 32 new students this quarter that have applied and were eligible for accommodations. We currently have 155 students enrolled in Spring quarter, but only 45 students have requested accommodations (20%). The theory is that with our online learning environment, student accommodations are being met through accessibility! Before COVID-19 we had 52% of eligible students requesting accommodations.

The accommodation that is utilized the most frequently during COVID-19 is testing, which includes additional time to complete exams/quizzes. The second most used accommodation is note taking. We use an online platform, Glean, to support note taking while on zoom or other learning platform. This provides the student with a recording that includes their notes embedded into the recording. This makes it easier for the student to study their notes!

Closed Captioning has been the most frequently requested accommodation, but ADA closed captioning (word for word) is only available to students who have a hearing impairment or an auditory processing disorder. However, auto captioning is available for both Zoom and Panopto thanks to the hard work done by Brad Cushman, PIO team, and Jeannie Henkle so all students can benefit! Closed captioning helps English language learners, students in a loud environment, students that are visual learners, and all students with disabilities. Student Access



Wenatchee Valley College - Student Access


OVERVIEW SPRING 2021

- WVC's Incident Command team continues to meet about issues surrounding COVID and the governor's higher education reopening plan and how it effects students and staff. The Governor has not updated the higher education plan and that makes planning for summer and fall classes more difficult. We are in a "high-flex" mode which includes face-to-face, hybrid, and remote classes. We will not at this time require vaccinations, except for those students living in the residence hall. We are encouraging students and staff to get the vaccine and are offering a vaccination clinic on campus on May 13. We expect the Governor to act soon, which will probably require vaccines for students and maybe staff. There would most likely have to be exemptions for medical, religious, and personal philosophical reasons.
- The Wells Replacement project continues and good progress is being made and generally the project remains on budget and close to the timeline.
- I continue to attend the SBCTC's weekly presidents' updates on COVID, budgets, enrollment and state and national directives that we have held since the beginning of March, 2020. Our most recent meetings have been on reopening campuses and vaccines.
- Community colleges fared well in the recent state budget passed by the legislature. I will discuss some of the details at the meeting on the 19th.
- The Foundation executive committee and full board have continued meeting through Zoom and I have attended and updated them on the situation at the college.
- Have attended Omak foundation board meetings by Zoom.
- WVC continues to deal with glitches in the ctcLink management software, but people are doing well with it generally. It does take more time to do many procedures in the new system, so we have had to look at back up positions in several areas and continue some overtime work.
- The PACE task force presented their recommendations to an all-district meeting and then to the cabinet. They did a great job putting them together and explaining them. Cabinet will discuss them again and then meet with the task force to work out next steps and moving forward.
- I have continued to meet with Erin Tofte and now including Reagan Bellamy to have conversations surrounding equity and inclusion at WVC.
- I attended the WACTC meetings in early May by Zoom. I continue as a member of the Capital Budget Committee. We did very well in capital this year with the most total dollars spent on community and technical college infrastructure in more than 10nyears. The legislative session and the budget were the focus of our meetings. We are met with Kris Johnson, the executive director of AWB about support for our programs which turn out students for fields in business that their members need to fill many positions for which they cannot find qualified applicants, also continuing our overarching focus on equity and inclusion. We also discussed a new program for internships that helps match students with

- Athletics has returned to play this spring with most of WVC's teams playing Eastern region teams only. There are be no championships as the season is coming to an end. We are testing athletes regularly and also use social distancing and masks when possible in practices.
- Have continued to meet with Heather Ryan, AHE president, to discuss legislation and other issues. They have been positive meetings which have opened communication.
- Met in person with the AIIS program advisory board (socially distanced and masked) it was an informative meeting.
- Interviewed and hired a replacement for Shandy Abrahamson in the Tribal Relations position, Gina Graham. She will start June 1.
- Spoke with representatives of the Northwest Equity Alliance about WVC's work on diversity, equity and inclusion at the college.
- Attended several Stand Against Racism presentations sponsored by the students on both campuses, and in partnership with the YWCA in Wenatchee.
- Held an all-district meeting "Coping with the Pandemic" presented by Dr. Kira Mauseth.
