

## **MAXIMUM ATTEMPTED CREDITS** (MAC) APPEAL FORM

Students who are close to or have exceeded the maximum attempted credits allowed for financial aid eligibility may appeal for an extension to our Satisfactory Progress policy when unusual circumstances beyond their control contributed to their failure to complete their degree within the allotted number of credits for that degree. ALL credits ATTEMPTED are counted for financial aid purposes, including W, I, N, F and P grades. Students with a Bachelors degree also need to complete this form and will only qualify for Federal Student Loans if the appeal is approved. If you have questions, contact our office.
